Prices - discounts

All prices are shown in euros (€) and apply per unit or per metre, unless explicitly stated otherwise. All our prices are shown exclusive of VAT. In view of the instability in commodity markets, all our prices are day prices. For the latest prices, we refer to our website at www.DYKA.be. Interim price changes may be made without prior notice. For various articles, no price is shown (*): these articles are available from stock in limited quantities, with prices on request. Discounts and payment terms are also available on request.

Delivery - packaging

Pipe lengths up to 6m and fittings: carriage paid in Belgium if the net invoice amount exceeds €250 exclusive of VAT. A fixed charge of €15 for freight and administration costs is made for orders for fittings only with a net invoice amount of less than €250 exclusive of VAT. This charge is €60 for orders for pipe lengths with a net invoice amount of less than €250 exclusive of VAT.

Urgent deliveries will be made by agreement, with charges for the actual transportation costs. For pipe lengths of more than 6m: carriage paid without unloading in Belgium, if delivery is made per fully loaded truck on a paved road. Separate freight costs are charged for supplies of smaller consignments of lengths of 10-12 to 20 metres in non-fully loaded trucks and for deliveries of pipes on reels, depending on the volume and destination. Extra delivery or unloading locations give rise to an extra surcharge. Differing pipe lengths must always be purchased in their totality and do not qualify for returns. If we make metal packaging available (e.g. U-containers, crates, reels), a deposit is charged for this. For reels, a separate rental fee is charged, which is not recoverable. Metal packaging remains the property of DYKA at all times. The deposit is credited on return of the packaging in good condition.

Creditworthiness

If, in the reasonable opinion of DYKA, the buyer's creditworthiness or ability to pay is, or could be, impaired, or if DYKA fails to obtain suitable credit insurance from third parties to cover the total outstanding amount due by the Buyer to the Seller, on conditions usually applied by the Seller in the context of normal business operations, the Buyer shall, at the request of DYKA, provide security for the payment in the form required by, and satisfactory to DYKA, for the account of the Buyer. In addition to any other measures, DYKA shall be entitled, without any prior notification being required, to suspend the delivery of products to the Buyer or to refuse to carry this out until such security has been provided. If no such security is provided within a maximum of 15 working days, DYKA is entitled to terminate the contract.

Complaints - returns

Complaints: the recipient must check that the goods delivered are consistent with the ordered specifications in terms of quantity and quality. We accept complaints in this regard only if we receive them in writing within five working days of delivery.

Returns are possible only for the latest models of standard products in as-new condition, subject to our prior written consent. Submission of the original invoice or delivery slip is required. Return costs of 10% of the net value of the equipment are charged, with a minimum of €6. If DYKA must collect its equipment, additional transport costs are charged. See the overview in the table.
